मुरबाड विधानसभेचे भाजपाचे माजी आमदार व सध्याचे बीआरएस पार्टीचे महाराष्ट्र प्रदेश उपाध्यक्ष दिगंबर विशे यांचे आज दुपारी वयाच्या ७२ व्या वर्षी हृदयविकाराच्या तीव्र झटक्याने निधन झाले. टोकावडे येथील रुग्णालयात त्यांना मृत घोषित करण्यात आले त्यांचे, त्यांच्या निधनाने मुरबाड तालुक्यातील राजकीय वर्तुळात शोककळा पसरली आहे.

१९९५च्या युतीच्या सरकारच्या काळात त्यांनी मुरबाड विधानसभेचे नेतृत्व केले होते. तर २००० च्या



निवडणुकीत अपक्ष लढताना पराभव पत्करावा लागला होता. काही काळासाठी त्यांनी भाजपला रामराम ठोकून काँग्रेस पक्षात प्रवेश केला होता मात्र पक्षातील मतभेद दूर झाल्याने ते पुन्हा भाजपात सक्रिय झाले होते. काही महिन्यांपूर्वीच त्यांनी राजकारणातून निवृत्ती जाहीर केली होती मात्र शेतकऱ्यांसाठी काम करणाऱ्या तेलंगणाचे मुख्यमंत्री के.सी. राव यांच्या बीआरएस पक्षाचे काम पाहून प्रभावित होऊन ते पुन्हा राजकारणात आले. त्यांच्यावर बीआरएस पक्षाच्या महाराष्ट्र प्रदेश उपाध्यक्ष पदाची जबाबदारी होती.

कोल्हापूरमधील श्री छत्रपती राजाराम सहकारी साखर कारखान्याच्या अपात्र सभासदांबाबत प्रादेशिक सहसंचालकांनी काल सुनावणी घेऊन निर्णय दिला. यावेळी १३४६ पैकी १२७२ सभासदांना अपात्र, तर ७४ सभासदांना पात्र ठरवण्यात आले. अपात्र ठरविण्यात आलेल्या सभासदांमध्ये माजी आमदार महादेवराव महाडिक यांच्या परिवारातील १० सदस्यांचा समावेश आहे, अशी माहिती आमदार स्तेज पाटील यांनी काँग्रेस कमिटीमध्ये झालेल्या पत्रकार परिषदेत दिली. उच्च न्यायालयात याबाबत आमची याचिका दाखल असून त्याला आम्ही ही निकाल पुरवणी म्हणून जोडणार आहोत, असेही त्यांनी स्पष्ट केले.
